


Mr. Randy Alvis, Chair called the Special Meeting to order and opened the meeting with the Pledge of Allegiance.

Mr. Alvis asked for a motion to approve the Agenda. Mr. Ronald Cameron so moved. Mr. Randy White seconded the motion, and the motion carried unanimously.

All in attendance boarded a bus, which was provided for the tour of potential sites for new construction. Dr. Keith Perrigan, Superintendent explained the process of the site selection and highlighted the tour would begin with the Exit 1 site. The tour consisted of visiting 13 different locations throughout the City. Dr. Perrigan gave details of each site and referenced to the packet provided to each participant. A question was presented as to the final decision of the site. Dr. Perrigan noted a call out went to all elementary parents as we wanted to be as open as possible and get feedback from parents, community members, City Council, School Board Members, etc. He noted in leadership role the final decision would be his, but stressed the importance of having feedback to assist in making the decision. A question was presented as to the process of the selection of site. Dr. Perrigan noted his hope was all the rubric would be turned in by the December board meeting. At this time, the board would narrow the selection. A Public Hearing would be held at each elementary school to receive feedback, questions/concerns. He also noted, he expected to receive an unsolicited bid in January. He noted that once we accepted the bid other companies would be able to bid within a 45-day window. He noted with that being done, we could have dirt being moved by late summer. Since 2011, the School Board Goals have reflected the direction they want to move in and have a two school elementary module.

The tour ended at 220 Lee Street and Mr. Alvis adjourned the meeting at 10:42 a.m.
